### **Intellectual Property Office**

- 1920 –Administration for the Protection of Industrial Property was founded and in November 2010 IPO celebrated its 90<sup>th</sup> anniversary
- Since its foundation, the Office was in charge for the protection of the industrial property and since 1994 for copyright and related rights
- Governmental organization responsible for administration, coordination and implementation of all IPR issues, supervised by Ministry of Science and Technological Development
- IPO Serbia became on October 1, 2010 38th member state of EPO
- Budgetary financed, 101 employees



### Office has four functions

- As a state body administers the granting procedures
- As a professional body keeps abreast with international regulations in the field IPR
- Cooperation with the business organizations
- Dissemination of information and educational function









### **New functions of the Office**

- Since the 2007 the Law on Ministries stipulates that IPO should not be responsible only for grant procedures but it should also be:
  - the central institution which would coordinate the work of other institutions in charge of IP enforcement and implementation
  - responsible for development IPR protection and educationalinformational activities in the field of IPR
- Within the EU funded project
   Educational and Information Center
   was founded in 2010 6 IPO staff trained
   for tailor made seminar delivery





### **New policy – service oriented Office**

#### Main goals:

- Information on nationally granted rights national databases for patents, trademarks and industrial design are accessible online
- Raising level of IP understanding
- Cooperation with main stakeholders groups





#### Achieved:

- Dissemination of the information on protected IPR
- Raising awareness activities started
- Tailor made service based on the needs of all main stakeholders groups
- Education and training service started in 2010




### **Special services**

- Patent searches in national/international databases:
  - Bibliographic searches based on bibliographic data, identification of analogue presence of foreign patent document in national database, legal status of patent document, status of EP patent document at national level
  - State of the art searches
  - Freedom to operate searches (FTO) in national database
  - Infringement searches
- Trademark and industrial design searches
- In Public Library IPO offers professional assistance to the customers in carrying out autonomous searches of the available patent and trademark databases



## **Domestic applicants – patent filing figures**






## **National IP Strategy**

- Drafting National IP Strategy based on the principles of National Strategy of Scientific and Technological Development (2010) and National Strategy for Sustainable Economic developments
- Clearly identified using of patent system and IP for protection of innovations
- Knowledge based development and economy
- IPO Serbia in charge for bringing together all relevant aspects for successful utilization of IP in Serbian economy
- Cooperation with all relevant Ministries and institutions:
  - Ministry of Science and Technological development, Ministry of Justice, Customs, Trade Inspectorate, Police, Chambers of Commerce, Ministry of Culture....
- National IP Strategy will be finished and adopted until the end of 2010

### Cooperation of IPO and business society

#### Main goal:

 To increase competitiveness of Serbian SMEs through enhancing innovativeness and raising awareness on the importance of IP among business society

#### Current situation i Serbia:

- 99,8% of companies are SMEs with 66,7% employees (2008)
- IPO Serbia has signed MoU with Serbian Chamber of Commerce as well as with 10(out of 16) Regional Chambers of Commerce
- MoU signed with the National Agency for Regional Development

#### • IPO activities:

- IPP Intellectual Property Pre-diagnosis
- IP seminars in Regional CoC, Train of Trainers WIPO seminar for CoC and National Agency for Regional Development staff
- Tailor made seminars for companies delivered by IPO staff



## **Cooperation with Academic Society**

- Main goal:
  - Establishing TTO units at each University in Serbia
- Achieved:
  - Cooperation Agreement with Technical Faculty in Novi Sad signed in 2008
  - Cooperation Agreement with Belgrade University signed and implementation plan for setting up the TTO developed in 2010
  - In 2010 TEMPUS project implementation started setting up TTOs at Novi Sad, Kragujevac and Nis Universities
- IPO activities:
  - Tailor made seminars
  - Proposal for cooperation with WIPO to renew and expand a special program "IP for Universities"



### **Strategy of Ministry of Science**

#### Current situation

- Technical faculties haven't established IP policy
- There is no IP educational program at technical faculties
- IP matters is introduced on personal professor's initiative

#### Expectations

- Patent applications/patents will be valuated for R&D funding
- Connecting R&D and business
- Raising entrepreneurial skills in publicly funded R&D organizations aimed to commercialize its results
- Consequence increased interests for IP matter from some faculties and R&D organizations



### Taylor made seminars for faculties and R&D institutions

- Underlying the importance of all IP aspect at the very beginning of research processes
- Introducing to patent system and different patent procedures
- Introduction to the world of patent information and what the patent information can bring to their R&D activities access to the latest technological developments, starting point for research, finding solutions, partners, etc.
- How to search through different publicly available patent databases –
   especial PATENTSCOPE®, RS national patent database through Publication Server and MIMOSA
- Importance of protecting R&D results before publication in other scientific literature



### **EIC** activities in 2010

EIC activities where at least basic information on patent system and patent information were introduced:

- 7 IP basic seminars in regional Chambers off Commerce
- WIPO-EIC Train of Trainers seminar
- TAIEX seminar on patent protection in SCC
- Participation in 3 business fairs,
- Participation in 2 exhibitions of inventions
- Organizing two IPA Regional Seminars
  - "IP Teaching in Higher Education"
  - "Software and CII Protection"
- 3 seminars for academic society
- In near future focus to faculties and R&D institutions, cooperation with TTO



### Cooperation with enforcement institutions

#### Main goal:

 Further strengthening of the cooperation between the various state institutions and enhancement of the enforcement of IPR

#### Achieved:

- MoU with Judicial Academy, in order to establish regular trainings for judges and prosecutors
- Within the EU funded project assessment of training needs regarding enforcement was conducted
- Within the EU regional program, Danish experts will conduct an evaluation of the possibility to create specialized IP courts

#### IPO activities:

Taylor made seminars for each enforcement group
